

STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I **Allan Coxon** DO SOLEMNLY AND SINCERELY DECLARE as follows :

Above [since the date of the statutory declaration referred to in 3. Above] ~~[other than those [highways with vehicular status] [bridleways] [footpaths] coloured purple on the plan accompanying this declaration].~~

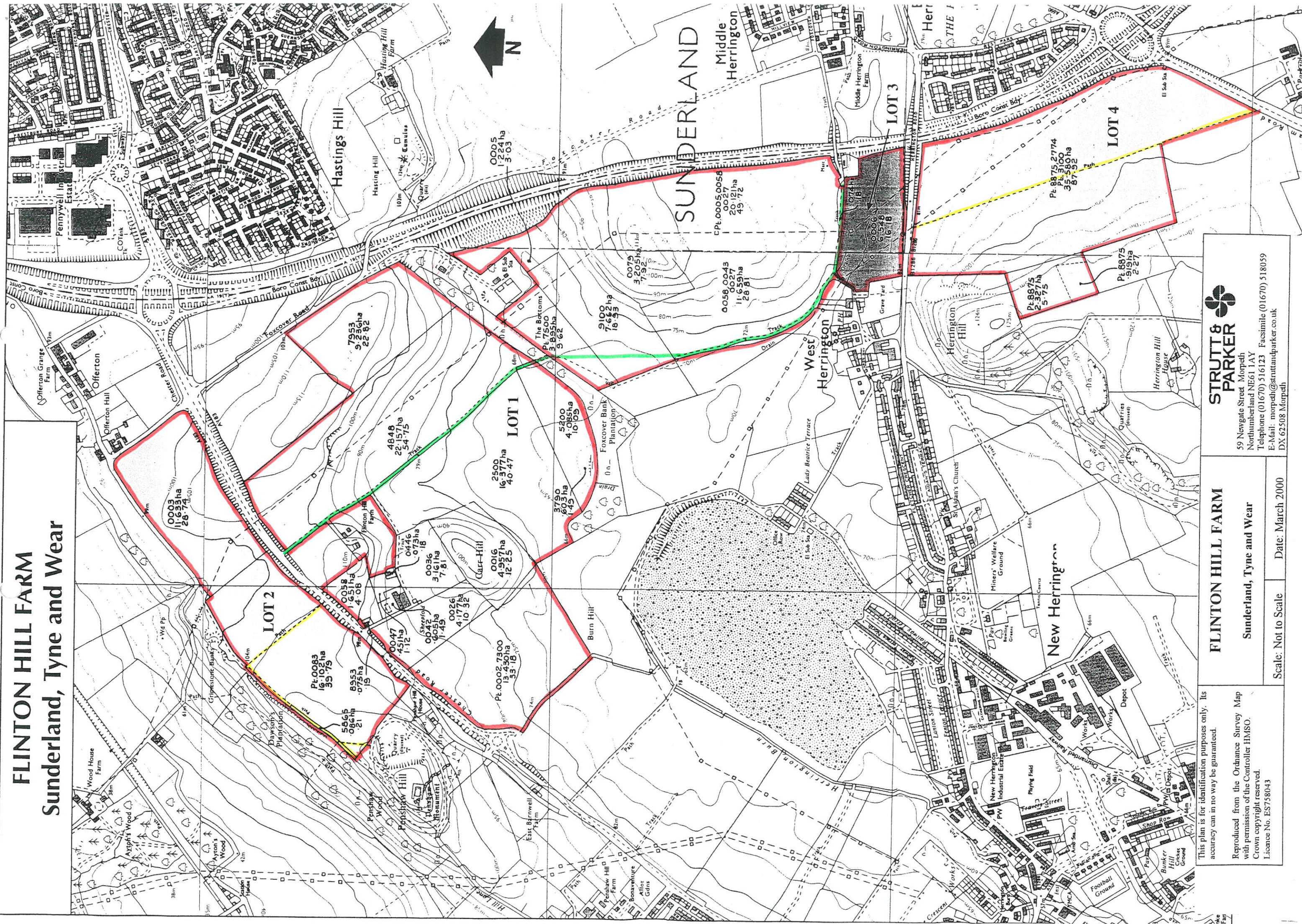
