# Bishopwearmouth Pubs Profile (Demolished) – The Star Inn/Mariners Arms 27 High Street West

## Summary of Research by John Tunman:

It looks as though there could have been some rebuilding of the High street West frontage between the Rain's Eye Plan of 1785 and the First Edition Ordnance Survey Map published in the 1850s. Consequently it is not clear whether the building housing the Star Inn as shown on the photographs in the profile pre-dates 1785, or was built sometime in the following 70 years.

The first reference to it as a public house was in the 1840s, listed as the Mariners Arms. It retained that name until around 1851, when it became the Star Inn. There was no obvious reason for the change in the name, as the licensee had the pub for 4 years before the change and continued as licensee for at least 2 years afterwards (1). The First Edition OS Map of 1857 shows it as having a very substantial footprint abutting Fold Yard, where the Friendly Tavern (later the Boilermakers Arms) was situated. Trade Directories reflected this juxtaposition (2). However, it seems that the structure was sub-divided at some point – probably in the 1870s, when a trade directory showed a greengrocer positioned between the Star Inn and the Boilermakers, with an adjustment in the street numbering to the Boilermakers from 28 to 29 High Street West in subsequent directories(3). This change is reflected in the Second Edition OS Map of 1897, which shows the building divided into two premises. The public house closed in 1920 and was converted into a shop like the adjoining premises which had once formed part of the public house had been, as can be seen from the photographs. They remained shops until their demolition in the 1980s to make way for the block of offices which now stand on the site.

There is little further information available regarding this public house and who used it. It is however known that it became the meeting place for striking Masons and Bricklayers in 1875, a letter having been written to the Sunderland Daily Echo regarding the dispute signed by "The Operative Masons" and sent from "Star Inn, High-street, Bishopwearmouth" (4). In the early 20th century there was a report of a walking race from Ryhope to "Sidney Stone's Star Inn, High-street West" (5)


At some point, George Bewick and Charlton became the owners of the pub, retaining it up to its closure. However, from 1910 they leased the premises out, first to Thomas Usher & Sons of Edinburgh then, in 1912, to Thomas McGowan, who also had the Victoria Villa in Grangetown; he remained lessee up to its closure in 1920. Upon closure compensation totalling £1,000 was paid to the parties with an interest in the premises, namely Mary Ann Coupland and George Bewick who received £425 each, whilst Thomas McGowan received £150 (1).

Concerning management, points to note are that Thomas Carr, the landlord, was granted a wine license in 1874 (6) and in 1915, Thomas McGowan, who leased the pub from 1912 up until its closure, was fined £10 for allowing betting to take place on the premises (1). It is not altogether clear what the circumstances were surrounding closure, other than that the Licensing Justices refused renewal of the license after Sergeant Suddick opposed it (7).





Rain's Eye Plan 1785




First Edition OS 1:2500 1857

## Map Regression

There looks to have been some rebuilding of the premises between the Rain's Eye Plan of 1785 and the First Edition OS map, a yard area to the west having been built over. The only map which identifies the Star as a Beerhouse is the ten foot to the mile OS Map of 1857, which shows it as a large premises. However the Second Edition OS Map of 1897 shows this building to have been sub-divided. This is borne out by the renumbering of properties to the east and the presence of a Greengrocer between the Star Inn and the Boilermakers in Wards Directory of 1877 and subsequent directories. The footprint of the building remains the same in subsequent editions of the Ordnance Survey Map of the locality.

How long had it been a pub? From circa 1841 to its closure in 1920, although its footprint was reduced by sub-division of the premises in the late 1870s. It was marked on the 10 feet to the mile OS Map of 1857 as a Beer House.

Who drank here?: There is limited evidence to suggest who might have drank at the Star Inn, however there is reference in a Historic Newspaper article to suggest that bricklayers and masons of Sunderland frequented the pub.

Brewery link: Unfortunately, there is no evidence to suggest a potential brewery link.
